

## **Privacy Policy**

Prairie Dent Repair is committed to maintaining the privacy of individuals and protecting personal information in its custody or control and complying with applicable privacy legislation. This privacy policy is a summary of Prairie Dent Repair's privacy practices and guidelines for our website at [www.PrairieDentRepair.ca](http://www.PrairieDentRepair.ca).

### **Collection, use and disclosure of personal Information**

We may collect, use, disclose and retain personal information for the following purposes:

- For billing, record-keeping and other client contact and service matters;;
- to send our newsletter to subscribers;
- to enable you to contact us by submitting a question/form on our website;
- to respond to inquiries from you; and
- to comply with legal or regulatory requirements.

Except as required for the foregoing, or as required or permitted by applicable law, Prairie Dent Repair does not disclose personal information to third parties without your prior consent.

### **Information collected when you use the site**

In certain circumstances the personal information we collect and maintain may include:

- your name, address, telephone number, email address or other information to contact or identify you;
- information about your transactions with us, including bills, credit history, payment preference, billing and credit card information, and other details and preferences;
- information from communications with you, including your feedback and requests for customer care;
- where required by law to do so; and
- site activity information and cookies (see below).

### **Cookies**

To enable certain features within the site, we assign to your internet browser (such as Microsoft Internet Explorer) a unique identification number stored in a file on your computer called a "cookie." Cookies are tiny text files written by an Internet server to a customer's browser when information is exchanged. Cookies make the web more useful by storing information about your preferences on a particular site.

A cookie automatically identifies your browser but not you to our computers whenever you log on to our site. Cookies contain only information the server computer "knew" in the first place and can only be read by the serving domain that placed them. The information that cookies collect includes the date and time of your visit, your registration information, session identification number, and your navigational history and preferences.

Cookies are an essential part of how the Internet works today and allow server computers to recognize your computer's browser when you return to a site. Most browsers are initially set to accept cookies. If you would prefer, you can set yours to refuse cookies, or to alert you with a warning when a website attempts to install a cookie on your computer. However, refusing cookies may not allow some functions of our website to occur.

Some third-party services providers may use cookies on our site. We have no control over those cookies and they are not covered by this privacy policy.

### **Consent and exceptions**

Prairie Dent Repair recognizes the importance of obtaining consent where required by law for collection, use and disclosure of your personal information. For the purpose of obtaining your consent, Prairie Dent Repair will consider the following:

- we may obtain your consent to our collection, use and disclosure of your information either expressly for stated purposes or impliedly when the purposes are not stated expressly but are indicated by the relevant circumstances or follow logically from other expressly stated purposes;
- for the consent to be informed, we will make reasonable efforts to advise you of all the purposes for which the personal information is being sought, unless the purposes are plain and obvious;
- we will make reasonable efforts to obtain consent for all anticipated purposes at the time of the collection of the personal information;
- we will obtain additional consent if we propose to use your personal information for a purpose for which express or implied consent was not initially obtained;

- we will not, as a condition of the supply of a product or service, require you to consent to the collection, use, or disclosure of information beyond that required to fulfill the explicitly specified purposes; and
- you may withdraw or amend any consent previously given by contacting our Privacy Officer, subject to any legal or contractual restrictions and upon reasonable notice to us.

The law provides certain exceptions to the usual requirement to obtain an individual's consent, for example:

- when collection and use is clearly in the interests of the individual and consent cannot be obtained in a timely way;
- in emergencies;
- where consent would compromise investigating a breach of contract or law;
- to collect a debt;
- to comply with rules of court relating to the production of information;
- in other circumstances where permitted or required by law.

### **Keeping your personal information secure**

Prairie Dent Repair uses appropriate security measures to protect against loss, theft, unauthorized access, disclosure, use or modification of personal information. Such measures will vary depending on the sensitivity, amount, format, nature and storage of the personal information and will involve, as applicable, physical, organizational and electronic security measures, including premises security, technological safeguards including security software and firewalls to prevent unauthorized computer access, and password and security policies.

We are not responsible for any breach of security or for any actions of any third parties that receive your personal information. We are not responsible for such third party privacy policies or how they treat information about their users.

### **Other websites**

Please note that our website and may contain links to other websites which are provided as a convenience for visitors to our website or users of our services only. Any third party websites will have their own privacy policies and practices, and we cannot be responsible for such third parties or their websites.

## **Updating your information and correcting errors**

## **Access to your personal information**
